Introduction

Executive Order (EO) 13423 of January 24, 2007, Strengthening Federal Environmental, Energy, and Transportation Management, requires Federal agencies to lead by example in advancing the nation's energy security and environmental performance.

The Executive Order consolidates and strengthens five executive orders and two memorandums of understanding and establishes new updated goals, practices, and reporting requirements for environmental, energy, and transportation performance and accountability.

Vision and Mission Statement

<u>Vision</u>: The Marine Air Ground Task Force Training Command (MAGTFTC), Marine Corps Air Ground Combat Center (MCAGCC) will meet and where possible, exceed the requirements of Executive Order 13423. Units and organizations will actively participate in raising environmental awareness by incorporating, adopting, and promoting progressive environmental standards and practices that demonstrate our commitment to leadership in sustainable energy and environmental excellence. The MAGTFTC/MCAGCC Green Council will provide Executive Level leadership and guidance to Combat Center units and organizations in achieving these federally mandated requirements.

<u>Mission</u>: The MAGTFTC/MCAGCC Green Council will provide a forum for education, professional discussion, developing goals and benchmarking progress. The Green Council shall review and evaluate plans, monitor implementation and compliance, facilitate the exchange of information on successful sustainability programs and practices, lessons learned, and record progress in the following areas:

- Increases in the purchase and fleet operation of alternative fuel, hybrid, plug-in hybrid, and electric vehicles;
- Reductions in the use of petroleum consumption as a result of increased use of fleet vehicles that utilize alternative forms of energy;
- Increases in alternative fuel consumption as a result of increased use of fleet vehicles that utilize alternative forms of energy;
- Reductions in energy intensity through the use of energy efficient equipment, lighting, and implementation of energy conservation programs;
- Reductions in greenhouse gas emissions through the use of alternative fuel vehicles and energy efficiency/conservation programs;
- Increases in the utilization of fuel and energy/power from renewable resources;
- Increases in building performance through the construction of new facilities and the renovation of existing facilities in accordance with adopted sustainability strategies;
- Increases in water conservation through the installation of water efficient landscaping, building fixtures, and the implementation of water conservation programs;

- Increases in procurement of environmentally friendly products, goods, and services from sustainable sources;
- Reductions in the use of chemicals and toxic materials as a mechanism for pollution prevention;
- Increases in compliance with the electronics management requirements to purchase, operate, reuse, donate, sell, or recycle electronics products;
- Increases in compliance in the utilization of environmental management systems;
- Other plans, reports, and briefs as MCAGCC Command authority deems necessary to meet and exceed the requirements of EO 13423
